## Troubleshooting the Teacher Licensure Course Status Report



The Department of Education and Workforce funds development of EMIS training materials as part of the EMIS Alliance grant. There is an expectation that ITCs will utilize these materials in training provided to your districts. #### Overview

- Teacher Licensure Course (TLC) Status Report
  - Includes all courses reported to EMIS and the proper certification status of the teacher of record
  - Is generated for all EMIS reporting entities and updated nightly
  - Is used to provide data for Local Report Cards (LRC) and for certain state and federal funding
  - Is used to create the ESSA State Licensure Assurances Report
  - Is used to create the Educator Access Data Analysis Tool
- This presentation will focus on troubleshooting the TLC Status Report, which is generated during the Initial Staff and Course (L) Collection



#### **Certification Data on LRC**

The LRC contains data from the Initial Staff and Course Collection that is used to populate the school and district details

The "not properly credentialed" teacher measure is also now on the Student Opportunity Profile within the LRC, which is getting more attention than staff measures have in the past

A district's high poverty schools are those ranked in the top quartile based on the percentage of the district's economically disadvantaged students. Low-poverty schools are those ranked in the bottom quartile based on the percentage of economically disadvantaged students. A district may have buildings in both quartiles, in just one quartile, or in neither quartile.



#### ESSA State Licensure Assurances Report

- Reflects the State certification and licensure determination for each core academic course, building, and teacher from the TLCS report
  - ESSA requires schools and programs receiving Title I funds to ensure that all teachers and paraprofessionals working in a program supported with these funds meet applicable state certification and licensure requirements
  - Finalized with the close of Initial Staff and Course (No Appeal)
    - Be sure to verify the TLCS report before the collection closes!
  - Arrived as a *Received* file in FY23 in January and February of 2023

    - Be sure to report correct credential IDs and staff names and question when either does not appear correctly on any of your reports



#### Equitable Access Data Analysis Tool


ODE Office of Educator Effectiveness provide districts this report to use for Title I equity planning

- District administrators will still use the analysis tool to identify student groups who have less access to quality educators

  - Wrap text header row
  - Freeze top row
  - Expand all columns
  - Apply filters

## Quick Check

The TLC Status Report is updated nightly and should be reviewed throughout the Initial Staff and Course Collection. Data on your report could appear based on another entity's reporting, so review the report even when you are not reporting any changes.

- Are you using the most recent version of the report?
- Have you corrected Level 1 Validation errors, excluded records, and missing staff?
- Are you able to open and format your TLC Status report?



# Understanding the TLC Status Report



#### **TLC Status Report Data**

- Data from the following collections are used to generate the TLC Status Report
  - Staff and Course (L) Collection Initial
  - Final Calendar (C) Collection
  - Beginning of Year Student (S) Collection
  - Midyear Student (S) Collection
  - SOES Beginning of Year Student (S) Collection
  - SOES End of Year Student (S) Collection
- Verify data is correct and complete in ALL noted collections
- Report is generated nightly with data submitted by 5pm throughout the Initial Staff and Course Collection
- The TLC Status Report is finalized at the close of the Initial Staff and Course (L) Collection
  - There is no appeal for Initial Staff and Course (L)



#### TLC Status Report Data

#### Contains one row per Local Classroom Code

- First 11 columns include:
  - Location IRN of the building where the course is being taught
  - Subject Code, Description, and Local Classroom Code
  - Teacher of Record and State Staff ID
  - Blank or incorrect staff name
    - CJ record issue not reported by another EMIS reporting entity (example: ESC)
    - Could be due to upper- and lower-case letters in state staff ID Verify ID

## Verify Staff and Courses

- Do **not** focus on errors only; review the entire report for accuracy and completeness
  - Are all building IRNs appearing on the report?
  - Are all teaching staff appearing as they should?
  - Are all courses for each building appearing on the report?
- Remember that total courses are the denominator for Local Report Card staff percentages, so it's important that every course is accounted for



## Verify Staff and Courses, cont'd

- The Department has been seeing an increase in the percentage of all courses that aren't reported in the Initial Staff/Course collection, but are reported only in the Final collection
  - Report all courses in the Initial Staff/Course collection that are possible to report
- Another reason for all courses to be reported as soon as possible during the year, is because the Department use this data to supply to the US Department of Education a list of areas where there is a need for more teachers, and therefore which areas teachers should be eligible for student loan waivers and forgiveness
  - Reporting all courses could open more of these opportunities for all teachers



#### Teacher of Record

The teacher who appears on the TLC Status Report is based on

- Teacher with greater amount of time teaching the course
- When multiple teachers are teaching the same amount of time
  - If both teachers are properly certified, the teacher selected on the report will depend on the processing order and could change from report to report
  - If one of the two teachers is properly certified, then the properly certified teacher will appear on the report each time it is generated
  - If no properly certified teacher is found, the report uses the first teacher it comes to and could change from report to report



#### **Course and Calendar Dates**

• Dates are used to determine a "course calendar"

- Grade Schedule (DL) Record First and Last Day of School
- Course Master (CN) Record Course Start and End Date
- Staff Course (CU) Record Staff Course Start and End Dates
- Student Course (GN) Record Course Enrollment Start and End Date
- The "course calendar" is then used to determine
  - Teacher who was with the course the longest
  - Students who are counted as being in the class
  - Location IRN is used for course calendar assignment
- Misaligned dates can cause teachers to appear as not properly certified



#### Location IRN

The building IRN where course is being taught

- District IRN should not be reported as the Location IRN
- Applies to LEAs that have both district and building IRNs
  - Traditional Districts
- Refer to reporting instructions in the EMIS Manual for Location IRN in section 4.2 Course Master (CN) Record
- Filter TLC Report for Location IRN
  - Unselect local building IRNs
  - Verify Location IRN's reported outside of District
  - Local district IRN should be changed to building IRN (when applicable)



#### Location IRN

#### A few exceptions (not a complete list)

- IRN of college who is granting credit for CCP course
- For CCP Course with delivery method of CP report the IRN of the location of the course per the CTE-26
- IRN of the location of the JVSD satellite course
- IRN of the building associated with the preschool license
- See additional reporting instructions for the Location IRN in the 4.2 Course Master (CN) Record section of the EMIS Manual

## Special Ed vs Regular Student Population

Student population is reported based on the content of the course

- If the content was modified for a special education population, report with an SE student population
  - Teacher must hold a special education license to appear as properly certified to teach a course with a student population of SE
- If the content is not modified for special education population, report with an RG student population
  - Teacher must hold an appropriate regular education license to appear as properly certified to teach a course with a student population of RG

#### Reported TLC IRN

- IRN of the <u>building</u> where this course will be used in the calculation of the percentage of core courses taught by properly certified/licensed staff
- Local, exempted village, or city school districts can report the IRN of one of their own buildings but should not report their district IRN for the TLC IRN
- Refer to EMIS Manual 4.3 Staff Course (CU) Record to review all reporting instructions for this element

#### Reported TLC IRN

- Report \*\*\*\*\* for non-core courses and for core courses where:
  - Curriculum element is
    - OC Expert Contracted from Outside Company/Organization for Credit Flex, PS- College Credit Plus, or PI – Postsecondary Instructor (not CCP)
  - or Delivery Method is
    - CC Correspondence Course, ET Educational Travel, or OL Online, and Educational Option is Yes
  - or Delivery Method is
    - ID Interactive Distance Learning, IM Internship/Mentorship, TO Test Out, or CI – Computer as Instructor
  - or Student Population is
    - D8 Preschool Special Education, DP Preschool Special Education Hearing/Visual, or PR – Preschool General Education



## Reported TLC IRN, cont'd

- When contracting a teacher of record from an EMIS reporting entity
  - Two common situations-
  - Contracted teacher is teaching only your students in a course in your building
    - Report the building IRN as the TLC IRN (same as Location IRN)
  - Contracted teacher is teaching students from multiple districts
    - Report the district IRN of the contracted entity
    - Location IRN is building where class is being taught
- See 4.3 Staff Course (CU) Record section of the EMIS Manual for additional reporting instructions



## Reported TLC IRN, cont'd

- Courses reported with a TLC IRN of another EMIS Reporting LEA should appear on both LEAs' TLC Status Reports when reported correctly
  - Contractor Staff Employment (CJ) Records are required to be reported by the entity employing the staff member but are not needed for the course and staff to appear on both contracted entities' TLC Status report
- Work with contracted EMIS Reporting entities to verify that teachers and their courses are appearing correctly
- Reporting Example
  - District A reports courses
  - ESC reports CJ record



## Staff Provider IRN

#### Reported on the Staff Course (CU) Record

- District IRN of the EMIS Reporting entity who employs the contracted staff
- Cannot be an IRN of a Non-EMIS Reporting entity
- Should be reported as \*\*\*\*\* if the staff member is not being contracted from another EMIS reporting entity
- Must be reported when the entity reporting the course is not reporting Staff Demographic (CI) and Staff Employment (CK) records for the staff member
- Filter on Staff Provider IRN to verify accuracy of reporting
  - Unselect \*\*\*\*\*
  - Verify remaining Staff Provider IRNs for accuracy



## **Derived Elements on TLC Status Report**

- Calculated TLC IRN
  - In most cases the calculated TLC IRN will match the TLC IRN reported for core courses
  - could be set to match the Location IRN when TLC IRN is reported as \*\*\*\*\* or reported with an IRN that is not a valid public school
  - non-core courses will be set to \*\*\*\*\*
- Credential Course Disability Indicator
  - derived from reported student population and students with disabilities who are enrolled in the course
  - are used to determine the Check Type
- Check Type Code
  - indicates the credential check that was used

- Check Type Code is S Special Situation Check

# Check Type Code E

• Ohio Revised Code Section 3302.151 allows city, local and exempted village school districts that meet certain criteria on the Ohio School Report Cards to be exempt from the teacher qualification requirements under the third-grade reading guarantee, the mentoring component under the Ohio teacher residency program, standards prescribing a minimum class size and requirement for teachers to be licensed specifically in the grade level in which they are teaching, except unless otherwise prescribed by federal law

- Districts are notified by letter if they are one of the exempt districts



This resource was created to assist districts in validating data that appear on the Teacher Licensure Course (TLC) Status Report generated by EMIS. For a list of the current subject codes, please see EMIS Manual Section 4.7. *This search has been updated for FY22.* 

### Search for Regular Teaching Certificates and Licenses

This search is for situations where a course master has been submitted and the student population is PR or RG (i.e., regular education courses). Every permissible combination is not found in this search. For instance, situations in which a teacher is required to have multiple teaching fields or multiple credentials do not appear.

Note that the general rule for elementary credentials (i.e., Kindergarten-Primary (KP), Kindergarten-Elementary (KE), Elementary (EL), Early Childhood (EC)) allows the teachers who hold these credentials to teach any course within the relevant grade range. These situations are not reflected within this search tool. An exception to this rule is for those initially hired on or after July 1, 2013, to teach physical education. These teachers must be licensed in PE and are included in this search tool.



# Not Properly Certified - No Students in Course

### Filter on TLC Result Code TL0005 (Critical)

- Student Grade Count columns for this course will contain blank values
- Verify that no students are enrolled in the course
  - Core courses reported with no students can negatively impact the ESSA report, so it is recommended to not report empty core courses to EMIS
  - These courses could negatively impact CTE funding. If this is a future term course, schedule students into the course or you will need to request an override from CTE if it is not CTE FTE funded



## Not Properly Certified - No Students in Course, cont'd

### Continue filtering on TLC Result Code TL0005 (Critical)

- Are there students being reported as enrolled in the course?
- Check the dates to be sure they are aligned
  - Calendar start and end dates
    - Uses the most common calendar dates for the majority of students in the course
  - Course Master (CN) Record start and end dates
  - Staff Course (CU) Record start and end dates
  - Student Course (GN) Record enrollment start and end dates



# Not Properly Certified – Credential/Course

### Filter on TLC Result Code TL0006 (Fatal)

- No Current Credential or Incorrect Student Population
- Staff not certified to teach this subject code or student population
  - Check certification to see if they can teach the subject code
  - Verify the student population, is it correct?
  - Check the students who are enrolled in the course to verify that they align with the student population element
  - Verify the grade levels of the students enrolled in the course
    - This result code can sometimes be generated instead of TL0009 which is the grade level check
  - Filter by that staff member to see all courses and student populations to verify



# Not Properly Certified – Credential/Course, cont'd

### Filter on TLC Result Code TL0006 (Fatal)

- No Current Credential or Incorrect Student Population
- When CTE teacher is on the TLC Status Report as not properly certified, is it necessary to request a CTE override for that teacher?
  - If granted, the override will allow the CTE FTE funding to flow but does not change that the teacher is not properly certified
  - Teachers will continue to appear as not properly certified on the TLCS report even when an override is granted
  - VM overrides are now automated

### Not Properly Certified - Substitute

Substitute Credential for traditional districts

### Filter on TLC Result Code TL0007 (Fatal)

- A long-term substitute can appear as properly certified when reported by a community school
- Substitute teachers who are providing instruction and assigning grades should be reported as the teacher of record, even if the teacher will be returning

# Quick Check

The TLC Status Report performs teacher certification checks using your EMIS data, as well as data from other LEAs, against the CORE database. Verify that your data is correct prior to the close of the Initial Staff and Course Collection.

# Summary

- The TLC Status Report contains both data to verify and issues to correct
- Some issues can be corrected, and some are simply stating the fact
- Work with district staff to verify that the data is both correct and complete
- "No errors" does not necessarily mean that your data is complete and accurate
- Use Excel functions to make troubleshooting easier
