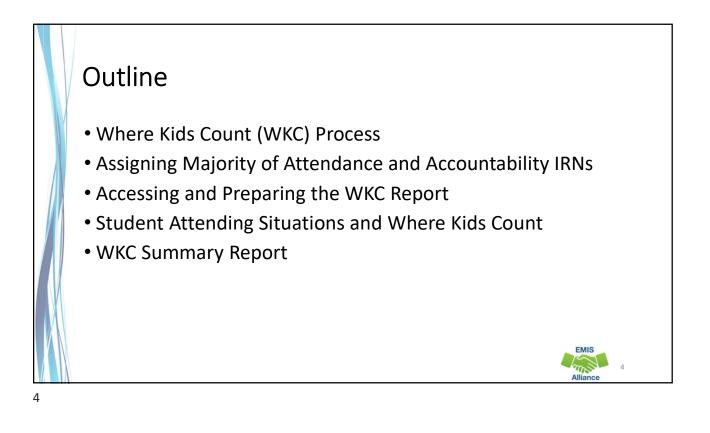


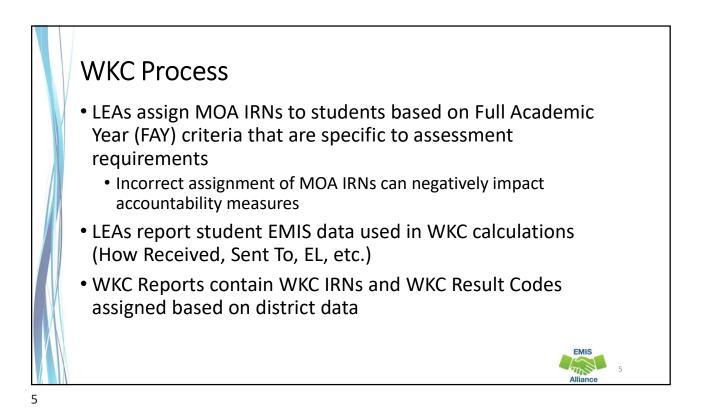
The Department of Education and Workforce funds development of EMIS training materials as part of the EMIS Alliance grant. That said, there are restrictions on use of the EMIS Alliance materials as follows: Materials developed as part of the EMIS Alliance program must be provided <u>at no cost</u> to your training participants. If you utilize the EMIS Alliance training materials – in whole or in part – you must <u>not</u> charge participants a fee to attend the class where the materials are used. Likewise, you may <u>not</u> use the materials or any portion thereof in any event where a fee is charged to attend. Exceptions must be approved in writing by the Department of Education and Workforce in advance of scheduling/promoting any event which may violate these restrictions.



FAY Exception

- When one of the following Sent Reasons is reported for a student on March 31^{st,} anytime during the school year, the student will count at the state level
 - CE Court-Ordered Institutional Placement in a facility as defined by ORC §2151.65 or §2152.41
 - CI All Court-Ordered Institutional Placements other than Foster Care and facilities defined by ORC §2151.65 or §2152.41
 - NI Non-Court-Ordered or Foster Care Institutional Placement
- Verify the correct MOA IRN assignment for these students





Software Demonstration





MOA IRNs and Accountability IRNs should be assigned and carefully reviewed for accuracy, as these are critical elements in the WKC process.

- Have accountability IRNs been assigned appropriately?



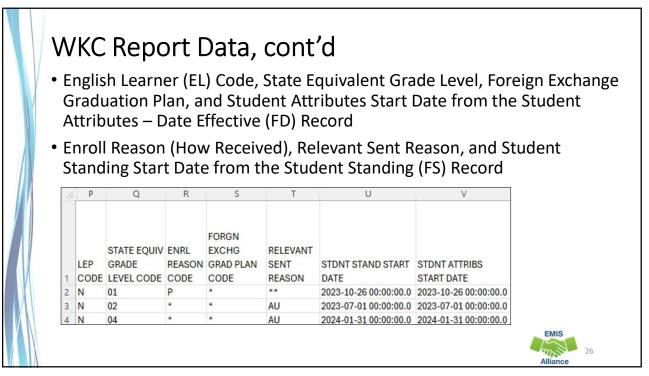










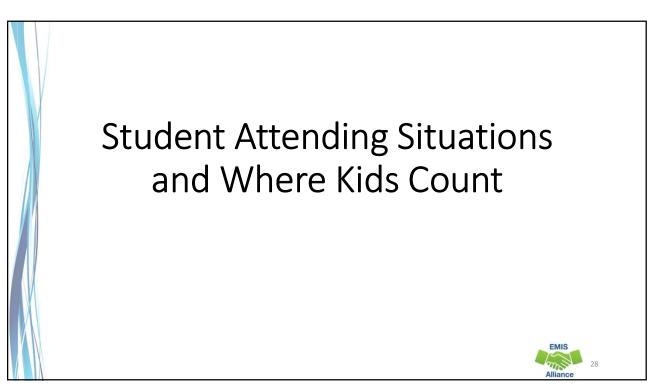



Quick Check




- Can you open and prepare the WKC Report from the Level 2 Reports?

- Are you sharing this report with other district staff for verification purposes?



















































WK0003: FAY and Multiple Buildings or District Only IRN

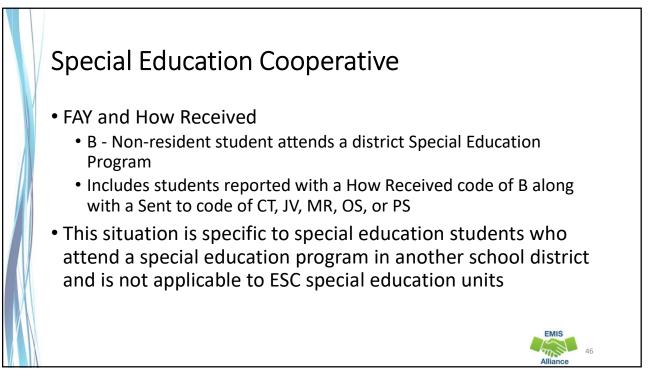

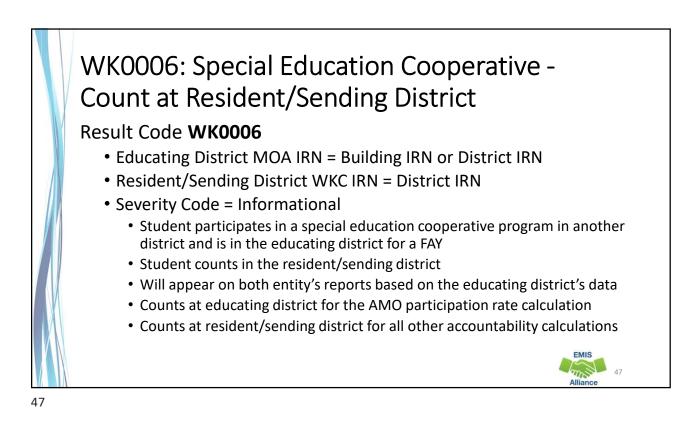
- MOA IRN = District IRN

 - Community schools and STEM districts will see this code since they have a district IRN and not a building IRN

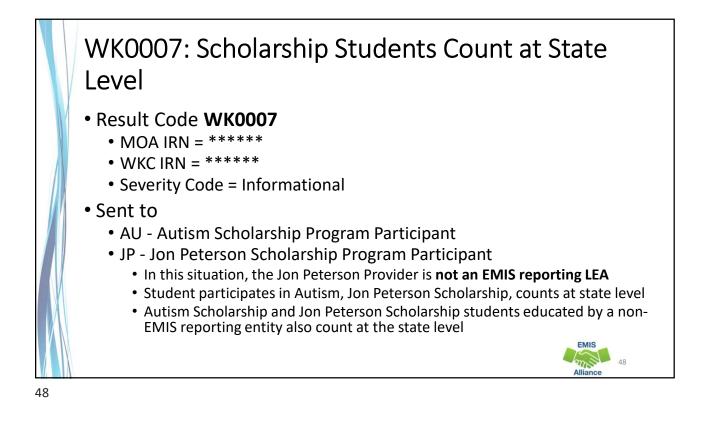


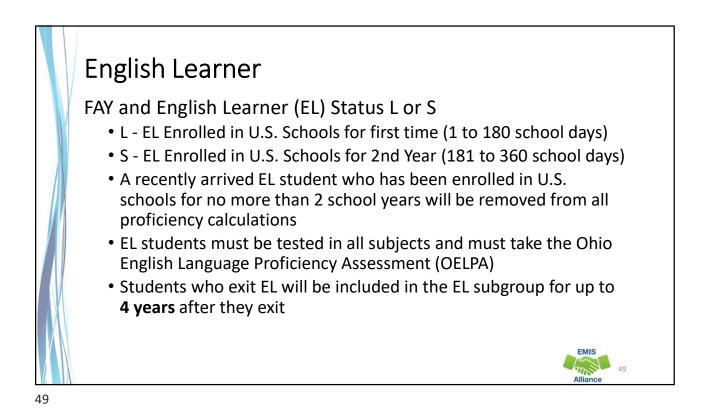




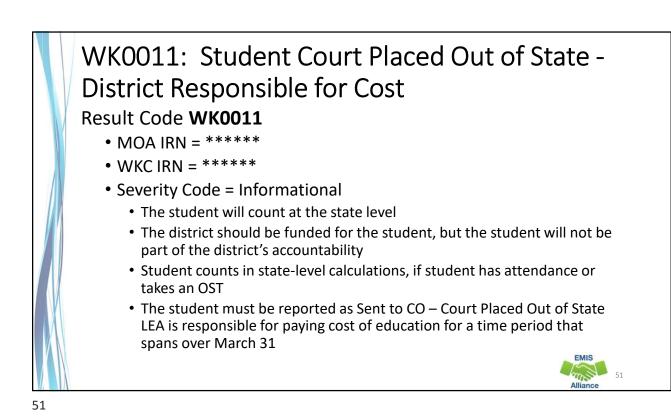

Compare prior year to current year to identify potential reporting issues

- What could be the reason for the critical severity codes for grade 23?
- What could be causing the warning severity codes for grades 13 and 23?
- A significant percentage change could be an indication of a data reporting issue.
