

Troubleshooting Career Technical Education (CTE) FTE Reports



The Ohio Department of Education and Workforce funds development of EMIS training materials as part of the EMIS Alliance grant. There is an expectation that ITCs will utilize these materials in training provided to your districts. CTE Report Data

- CTE reports use EMIS data from
 - Initial and Final Staff and Course (L) Collections
 - Calendar (C) Collections
 - Student (S) Collections
- CTE reports are updated nightly using EMIS data submitted as of 5pm
- CTE reports can contain EMIS data from other LEAs



Level 2 Report Dates

- Process date – when DEW successfully processed the data used in the report for the entire state
- Last Updated date – when report was updated with data that added, changed or removed rows. If no rows changed, then the date remains unchanged
- Submission – when LEA submitted data

Dates do not always appear as updated even though data has processed correctly (ITCs can report instances to DEW)

Fatal severity codes occur when the CTE FTE Adjusted FTE is zero

Critical severity codes occur when the CTE FTE Adjusted FTE is less than the Original FTE but is not reduced to zero

Informational severity codes will appear when the Adjusted FTE and Original FTE are the equal

It is recommended to review the entire report and not just focus on errors

Formatting the (CTEA-000) CTE FTE Detail Report

- Open the (CTEA-000) CTE FTE Detail Report
- Select Header Row and Wrap Text
- Freeze Top Row
- Justify column width
- Apply Filters
- Better yet, use a macro!

Quick Check

CTE reports contain a large amount of data and should be reviewed often. Knowing how to prepare the reports using Excel can make the data review process much easier. Saving your work between reviews can be helpful in troubleshooting issues over time.

- Are you able to access your most recent CTE reports?
- Have your reports been updated since your last review?
- Can you format the CTE reports to prepare them for review?

Understanding the CTE FTE Detail Report

(CTEA-000) CTE FTE Detail Report Data

Contains rows of CTE data by student and CTE course in which they are enrolled

- Students with changes to their Student Standing (FS), Student Attributes Date Effective (FD), or Student Course (GN) Records can have multiple rows of data on the CTE FTE Detail Report

Result Code “SC0000” and Result Code Description “CTE Base FTE” are not error codes but are simply placeholders

The first column contains the IRN of the LEA receiving the report

(CTEA-000) CTE FTE Detail Report Data, cont'd

The Severity Code is set based on a comparison between the original FTE and the adjusted FTE

- CTE FTEs with an “F” Fatal Severity Code are reduced to zero
- CTE FTEs with a “C” Critical Severity Code are reduced but not to zero
- CTE FTEs with an “I” Information Severity Code are not reduced

CTE FTEs

Career Tech is funded through student CTE FTEs

- Students associated with multiple LEAs can appear on more than one (CTEA-000) CTE FTE Detail Report
 - For example, students who attend another LEA for Contract Career Tech or through a Special Education Cooperative will appear on the educating and resident district's (CTEA-000) CTE FTE Detail Report since the funding passes through the resident district
- CTE FTEs are calculated for each row on the report
 - Students can have multiple CTE FTEs calculated for the same course due to changes to their Student Standing (FS), Student Attribute Effective Date (FD), or Student Course (GN) Records

FTE Fund Patterns

- FTE Fund Pattern Codes (Column S)
 - Indicate how the funds will flow for that specific CTE FTE row
 - Examples - RGJV, CTVC, SPCO, etc.
- Initially Funded IRN (Column AB)
 - CTE FTE funding initially goes to this IRN
- Transferred to IRN (Column AA)
 - CTE FTE funding will be transferred to this IRN
 - When blank, the funding goes to the Initially Funded IRN

Inclusion Codes

- Inclusion Codes (Column AJ) indicate where the CTE FTE will be counted
 - FULL – included in the ADM of the LEA receiving the report
 - NONE – not included in the ADM of the LEA receiving the report
- Since most funding now flows directly to the educating entity, inclusion codes will most often appear as FULL
 - Situations where transfers will still occur are
 - Contract Career Tech students
 - Special Education Cooperative students

CTE Categories, Subject Codes, and Programs

CTE FUND CAT Number Column T

- Category 1: WFD in Agriculture and Environmental Systems, Construction Technologies, Engineering and Science Technologies, Finance, Health Science, Information Technology and Manufacturing Technologies (highest CTE funding category)
- Category 2: WFD in Business Administration, Hospitality and Tourism, Human Services, Law and Public Safety, Transportation Systems and Arts and Communications
- Category 3: Career Based Intervention Programs
- Category 4: WFD in Education and Training, marketing, WFD in Academics, Public Administration and Career Development
- Category 5: Family and Consumer Science Programs (lowest CTE funding category)

CTE Category 0

- CTE FTE Category Number of 0
 - Occurs when a course with an academic subject code is reported with
 - a curriculum element of PS – College Credit Plus
 - and a Delivery Method Element of CP - Career Tech College Credit Plus Course
 - Occurs when a course is reported with a CTE curriculum element with a non-CTE subject code
 - These courses do not generate career tech funding
- Filter your CTE FTE Detail report on column
 - CTE FUND CAT NUMBER
 - Filter on “0”

Calculating CTE FTEs

- Original FTE
 - Calculated using student, course, and calendar EMIS data
- Adjusted FTE
 - Original FTE minus any adjustments applied from errors

Original CTE FTE Calculation

Calculating the Original CTE FTE (aka Base or Potential CTE FTE)

- Numerator
 - (Student Course Days/Course Days) x Length of Scheduled Instruction
 - Student Course Days – days enrolled in course using the student's assigned calendar
 - Course Days – calendar days between course start and end from the Course Master (CN) Record
 - Length of Scheduled Instruction
- Denominator
 - Community Schools 920 hours
 - Other LEAs (including STEM districts) 1080 hours

Course Days

- Use the Calendar Display Report to calculate
 - Course Days
 - Student Course Days
- Access the Calendar_Display.csv file from the submission files (aka preview or review files) in the Calendar Collection

| Student Session Days | Student Session Hours | Student YTD Days | Student YTD Hours |
|----------------------|-----------------------|------------------|-------------------|
| 1 | 6.17 | 4 | 24.68 |
| 5 | 30.85 | 9 | 55.53 |

Sum the Student Session Days for the length of the course and for time the student was enrolled in the course

Non-Community School CTE Student Example

- Student enrolled in course for 180 days
- Course days equal 180
- Length of Scheduled Instruction is 360 hours

(Student Course Days/Course Days) x Length of Scheduled Instruction
1080 hours

$$\frac{(180/180) \times 360}{1080} = \mathbf{0.333333}$$

Community School CTE Student Example

- Student enrolled in course for 172 days
- Course days equal 172
- Length of Scheduled Instruction is 360 hours

(Student Course Days/Course Days) x Length of Scheduled Instruction
920 hours

$$\frac{(172/172) \times 360}{920} = \mathbf{0.391304}$$

Quick Check

The (CTEA-000) CTE FTE Detail Report contains data that should be verified. Errors should be corrected when possible. Review all of the data for accuracy and completeness.

- Are all approved CTE program students appearing on the report?
- Are the CTE FTEs being calculated correctly?

- When multiple teachers are associated with a course, the teacher who appeared on the Teacher Licensure Course Status Report (TLC) will be listed on this report
- Errors on the (CTEA-003) CTE Staff Error Detail Report can affect an entire classroom of students, so a single line on this report could cause multiple students to be affected on the (CTEA-000) CTE FTE Detail Report

Staff Error Result Code SF0002

Teacher does not have appropriate certificate/license to teach course

- CTE FTE is reduced to zero (Fatal)
- Verify the teacher's licensure using the Educator Search Tool
 - <https://core.ode.state.oh.us/Core4/ODE.CORE.Lic.Profile.Public.UI/>
- Initial Staff and Course (L) data is used for this check
- If the teacher is certified to teach the course and you are seeing this error, verify the course is coded correctly
 - Contact the Office of Career Tech to request an override if applicable

Staff Error Result Code SF0004

The total CTE length of scheduled instruction for this teacher is greater than 1080 hours

- CTE FTE is reduced (Critical)
- Do Mapped Local Classroom Code (CM) Records need to be reported?

- Is this teacher teaching at multiple LEAs?

- CTE FTE is reduced to zero (Fatal)
- Adjustment generated when course does not have a teacher assigned
- Check that a valid staff member is assigned to this course during Initial Staff and Course (L)
 - If staff member was not reported, then no CTE FTE funding is generated
 - Look for a fatal error or an excluded staff issue in the Staff and Course (L) Collection
- If incorrectly reported in Initial L, correct the data in Final L and if the change does not correct the problem create a helpdesk ticket to DEW and they will determine if it can be corrected

Staff Error Result Code SF0007

The total length of scheduled CCP CTE instruction for this teacher is greater than 1080 hours

- CTE FTE for students taught by this teacher is reduced by a factor equal to $1080 / \text{Total Length of Scheduled Instruction}$

- Do any of these classes need to be mapped together?

Student Error Result Code SC0001

CBI student not coded as disadvantaged or having a disability

- CTE FTE is reduced to zero (Fatal)
- For the duration of the student's enrollment in a Career Based Intervention Program (subject code 252525), disadvantagement must be reported as
 - Academically disadvantaged, or
 - Economically disadvantaged, or
 - Disability code
 - Note that students with a disability should not be reported as academically disadvantaged
- Refer to the FD section of the EMIS Manual for detailed reporting instructions for the disadvantaged and disability elements

Student Error Result Code SC0003

Grade level not valid for curriculum code

- CTE FTE is reduced to zero (Fatal)
- If Curriculum Code is **NOT** VM - CTE Middle Grade Course, students must be in grade levels 7 and higher
- Verify student state equivalent grade level reported on the Student Attributes Effective Date (FD) Record
- Grade level appears on the Student Error Detail report for quick reference
- If the data is correct, the error remains

Student Error Result Code SC0006

VP course does not have a valid subject code

- CTE FTE is reduced to zero (Fatal)
- Note that Result Code Description on the report states - VP course does not have a valid “curriculum code”, which should be “subject code”

- Verify that the subject code is valid for this VP course

Student Error Result Code SC0009

V3 pre-apprenticeship or entrepreneurship course not correlated

- CTE FTE is reduced to zero (Fatal)
- Course with curriculum code V3-CTE Related/Correlated and subject code of
 - 990361 Entrepreneurship Skills or
 - 990363 Essential Skills for Business or
 - 990365 Pre-Apprenticeship
- Must be correlated to an anchor course with a curriculum code of
 - VT-CTE Tech Prep Non-Cooperative Based Anchor or
 - VP-CTE Tech Prep Cooperative Program Anchor
 - see list of subject code options in the CTE FTE Report Explanation

Student Error Result Code SC0013

Grade level not valid for curriculum code VM

- CTE FTE is reduced to zero (Fatal)
- Verify that the students in this VM - CTE Middle Grade Course are in grades 07, 08, 09, or 10
 - Exception – students enrolled in a course with a subject code of 990364 with curriculum code of VM must be in grades 07, 08, or 09
 - Verify student state equivalent grade level reported on the Student Attributes Effective Date (FD) Record
 - Grade level appears on the Student Error Detail report for quick reference
 - Verify that the curriculum code of VM is correct, see the CTE-26

Student Error Result Code SC0014

Student's single course level CTE FTE is greater than student's regular FTE

- CTE FTE is reduced (Fatal)
- Occurs when the CTE FTE is greater than the regular base FTE
- CTE FTE is reduced to be no more than the base FTE
- Course-level FTE greater than student regular FTE due to
 - Incorrect student enrollment
 - Duplicate course reporting
 - Incorrect Length of Scheduled Instruction (CN100) for career tech course
 - Student enrolled in a CTE Course that generates a CTE FTE that is greater than the student's base FTE and if correctly reported, should be ignored

Student Error Result Code SC0015

Student's total CTE FTE is greater than student's regular FTE

- CTE FTE is reduced (Fatal)
- If student's total adjusted CTE FTE is greater than their total regular base FTE multiplied by 1.1 then the student's total CTE FTE is reduced to be no more than the total regular base FTE multiplied by 1.1
- This occurs when the total length of instruction for the CTE courses taken by a student exceeds 1080 for traditional districts and JVSDs or 920 hours for community schools
- Can occur when courses are split (duplicated) due to changes on Student Standing (FS) or Student Attributes (FD)

Student Error Result Code SC0016

Subject code not valid for curriculum code VA or VB

- CTE FTE is reduced to zero (Fatal)
- VA CTE Applied Academic and VB CTE Applied Academic Advanced Placement
 - Cannot be reported with subject codes
 - 050014 Intervention English
 - 050119 Intervention Reading
 - 111950 Intervention Mathematics
 - 110190 Transition to High School Mathematics
 - 150400 Intervention Social Studies
 - 132900 Intervention Science
- Verify the curriculum code and subject codes are reported correctly for this course as they appear on the CTE-26

Student Error Result Code SC0017

Student has a non-fundable fund pattern code

- CTE FTE is reduced to zero (Fatal)
- **NFRG** Non-fundable situation
- **NFER** Not fundable, based on errors in coding
- The student will appear with a non-fundable FTE Fund Pattern Code on the current Student Collection, Level 2 Reports, (FTED-001) FTE Detail Report
- Verify this student's EMIS coding on the Student Standing (FS) and Student Attributes Effective Date (FD) Records
- Verify EMIS student data in ODDEX History for shared students

Student Error Result Code SC0019

Negative CTE FTE

- CTE FTE is reduced to zero (Fatal)
- When a course taken by a student generates multiple CTE FTE adjustments that result in the total adjusted CTE FTE for the course being a negative number, then a positive adjustment is generated to bring the total adjusted CTE FTE for the course up to zero

Student Error Result Code SC0020

Grade Level not valid for a Senior Only Industry Credential Subject Code

- CTE FTE is reduced to zero (Fatal)
- Students enrolled in a Senior Only Industry Credential course must be in grade 11 or higher for a Dropout Prevention and Recovery School, or Ohio Technical Center (OTC)
- And in Grade 12 or higher for all other LEA types
- Verify the accuracy of the subject code and the student's grade level

Student Error Result Code SC0021

Industry Credential Only at DORP Negative CTE FTE

- CTE FTE is reduced to zero (Fatal)
- For students taking Industry Credential Only (ICO) courses at a Dropout Prevention and Recovery (DOPR) community school, the CTE FTE generated for the ICO courses is reduced to zero
- If the student is taking any non-ICO courses, then the CTE FTE generated for those courses is also reduced to zero for the days that overlap with the ICO courses
- If the CTE funding category for any course that generates the SC0021 adjustment is category 2 or higher, then the ERR VALUE 1 TEXT column (on the CTE FTE Detail Report) will indicate that the course will be moved away from that funding category to category 1
- When there is an SC0021 adjustment, there will always be a corresponding SC0022 adjustment for each ICO course

Student Error Result Code SC0022

Industry Credential Only at DORP Positive CTE FTE

- This is a positive adjustment (Informational) Note - as of 3/6/2024 listed as fatal
- For students taking ICO courses at a DOPR community school, the CTE FTE for the days that the student is enrolled in an ICO course is calculated as a full-time FTE and added as a positive CTE FTE adjustment at the category 1 funding level
- The SC0022 calculation is (Number of Calendar Days Enrolled in an ICO Course / Total Calendar Days) / Number of ICO Courses Taken
 - For example, if a student is enrolled in two ICO courses for 90 days and the student is on a calendar with 180 days, then each ICO course will generate an SC0022 adjustment of 0.25 CTE FTE for a total of 0.50 CTE FTE
 - This represents the maximum CTE FTE the student could generate for 90 days of enrollment based on a 180-day calendar

Quick Check

Resolving CTE FTE errors can require data correction and can sometimes require contacting the Office of Career Tech or the DEW EMIS Office

- Are you using the CTE FTE Report Explanation to understand the errors?
- Does the EMIS data align with the CTE-26 and the CTE Program and Assessment Matrix?
- Are you submitting updated EMIS data as changes are made?

CTE Overrides

- When CTE EMIS data is correct and CTE errors are generated, sometimes it is appropriate to request an override
- Note that some CTE overrides are now automated
- See October 20, 2025 EMIS Newsflash for more information regarding overrides
- Once an override is approved, a CTE Approved Override Report will be generated in the Staff and Course (L) Collection Level 2 Reports

CTE Overrides, cont'd

- There is no notice given when a CTE Approved Override Report is generated in the Staff and Course (L) Collection Level 2 Reports, so districts will need to periodically check their reports to see if the override was approved
- The approved override will restore the CTE FTE for students affected by the error and the error will no longer appear in a CTE error report
- Note that an approved CTE Override will not correct issues on the Teacher Licensure Course Status Report.

CTE Approved Overrides

(CTEA-006) CTE Approved Overrides Report

- contains students who had adjusted CTE FTEs due to any type of error (student, course, or staff errors) for which an override was approved

The Adjusted FTE column will contain the CTE FTE amount that is being restored due to the approved override – check against detail to see that this is happening



Quick Check

CTE overrides are sometimes necessary to allow CTE programs to be funded correctly. An override request can sometimes take a considerable amount of time to process. Submitting override requests as early as possible is recommended.

- Have you identified an issue that may require a CTE override?
- Have you contacted the Office of Career Tech to request an override?
- Did you check to see that a (CTEA-006) CTE Approved Overrides Report was received?

CTE FTE Daily Summary Reports

CTE FTE Daily Summary Reports

- Contain student CTE FTEs calculated from EMIS data that was processed on ten specific dates
- Should be reviewed often to identify fluctuations in the amount of CTE FTEs being generated from specific submissions
- Contain result codes that are not an indication of an error but rather identify student education/funding situations
- Are separated by educating/funding situations which can be tied back to the CTE FTE Detail Report
 - Steps to match to CTE FTE Detail can be found in prior year versions of this training at <https://community.mcoecn.org/display/EM/EMIS+Alliance+Public+Space>

CTE FTE Daily Summary Reports, cont'd

- (CTEA-007) CTE FTE Daily Summary Report – Students District is Educating
 - Contains CTE FTEs summed by CTE Fund Category Number
- (CTEA-008) CTE FTE Daily Summary Report – Students Initially Funded at District
 - Contains CTE FTEs summed by Result Code and CTE Fund Category Number
- (CTEA-009) CTE FTE Daily Summary Report – Transfers
 - Contains CTE FTEs summed by Result Code and CTE Fund Category Number

- All three daily summary reports contain the same 10 Run Date Columns
- Most recent CTE FTEs are to the left and prior CTE FTEs are to the right

Error Severity looks at the Thirty Day Average value and compares it to the value from the Latest Run to draw attention to differences that may be of concern. You can miss this if you don't look at the report often.

 - Result Code SC0110 – no transfer of funds
 - Result Code SC0120 – funds transferred to a JVSD
 - Result Code SC0140 – funds transferred to another district

CTEA-009 Transfers

- Includes CTE FTEs that will either transfer in or out from the LEA receiving the report (positive and/or negative amounts)
- Includes CTE FTEs for students who are
 - SC0170 – Non-open enrolled in, initially funded elsewhere then funding is transferred to educating LEA (positive amount)
 - SC0180 – Non-open enrolled out, initially funded then funding is transferred to the educating LEA (negative amount)

- Any LEA type with CTE FTE transfers can receive this report
- Note the positive and negative transfers as well as the transfer IRNs

Quick Check

CTE FTE Daily Summary Reports are helpful to identify fluctuations in CTE FTEs that could affect funding. They can also be used to follow the flow of CTE funding based on student situations.

- Are you checking the Daily Summary reports often to avoid any negative impacts on CTE funding?
- Can you identify individual students in the Daily Summary reports by filtering the CTE FTE Detail Report?
- Are you sharing these reports with others in your district?

Summary

- CTE reports contain data to verify and issues to correct
- The troubleshooting process requires interaction between the CTE FTE Detail Report and the error reports
- Use the CTE FTE Summary Reports to verify data and to compare data from previous versions of the reports
- Confirm that corrections have been made in the source system and that new EMIS data has been submitted for CTE reports to be updated
