

# Troubleshooting FTE Reports Part Two

  - Beginning of Year Student Collection
  - Midyear Student Collection
  - End of Year Student Collection
- Community schools and STEM schools
  - SOES Beginning of Year Student Collection
  - SOES End of Year Student Collection
- All LEAs should submit data through the Student Cross Reference(SCR) Collection when the above Student Collections are processed
- Data must be submitted to be processed by DEW for reports to be generated
- FTE Reports use data from the Calendar Collections and can also use data from the Staff and Course Collections

FTE Summary Reports can be used to provide a high-level view of student FTE data as well as multiple student level views. The reports can aid in data comparisons based on fund patterns, student totals, and student adjustments.

# Understanding the FTE Daily Summary Reports

# FTE Daily Summary Reports

- Contain student FTEs calculated from EMIS data that was processed at ten specific times
- Should be reviewed often to identify fluctuations in the number of FTEs being generated from specific submissions
- Contain result codes that are not an indication of an error but rather identify student education/funding situations
- Contain FTE totals separated by unique combinations of
  - Result Code
  - Grade Span Code
  - Economic Disadvantage Flag
  - Special Education Category Code
  - English Learner Category
  - Gifted Identified Code

## FTE Daily Summary Reports, cont'd

- (FTES-005) FTE Daily Summary Report - Students District is Educating
  - Contains FTE totals for students the LEA receiving the report is educating
- (FTES-006) FTE Daily Summary Report - Students Initially Funded at District
  - Contains FTE totals for students the LEA receiving the report is initially funded
- (FTES-007) FTE Daily Summary Report - Transfers
  - Contains FTEs by student situation whose funding is transferred in and out from the LEA receiving the report

# FTE Run Dates

All three Daily Summary Reports contain the same 10 Run Date columns

- Most recent FTEs are to the left and prior FTEs are to the right
- Run columns can contain zeros at the beginning of a collection
- Thirty-Day Averages can sometimes populate incorrectly until sufficient data is processed



# Error Severity Codes

Error Severity looks at the Thirty Day Average value and compares it to the value from the Latest Run to draw attention to differences that may be of concern

- The Fatal (F) Error Severity Code indicates a drop from the Thirty Day Average value to zero
- Critical (C) indicates a decrease of 10% or more (but not to zero) in the Latest Run
- Warning (W) indicates a decrease of 5% to 10% but not to zero or an increase of 20% or more

# Error Severity Codes, cont'd

This example contains a Critical Error Severity Code due to a decrease in FTE between the Latest Run and the Thirty-Day Average

- Remember that the Thirty-Day Averages can be incorrect at the beginning of a collection until enough data has been submitted

## (FTES-005) Students District is Educating

- Includes FTEs for students the LEA is educating regardless if the district is initially funded or if the funding will transfer to another LEA
- Result Code is FT0100 - Students LEA is educating
  - This is the only result code on the FTES-005 Report
  - Can appear for any LEA type

## (FTES-006) Students Initially Funded at District

- Includes FTEs of students for which the LEA is initially funded
- Generated for most LEA types, except ESCs and State schools
- Contains up to seven different Result Codes indicating the LEA is initially funded and breaks down transfer information by student situation
  - Each row on the FTE Detail Report will count in only one result code
  - JVSDs, Community schools, and STEM districts receive only Result Code FT0110 on their report
- Displays FTEs as initially funded, positive amounts

## (FTES-006) Initially Funded Result Codes

- FT0110 - Initially Funded, No Transfer
- FT0111 - Preschool Students Initially Funded, Transferred to the ESC
- FT0112 - Open Enrolled Preschool Students Initially Funded at the LEA and Funds Transferred to Another District
- FT0113 - Preschool Students Initially Funded at the LEA Transferred to a CBDD

## (FTES-006) Initially Funded Result Codes, cont'd

- FT0114 - Initially Funded at the LEA Transferred to a JVSD
  - Used for Contract Career Tech transfers from the sending district to the JVSD
- FT0116 - Initially Funded at the LEA Transferred to Another District
  - Used for special education cooperative students and contract career-tech students
- FT0119 - JVSD/Compact 20% counted in sending district's enrolled ADM
  - Appear on sending LEA's FTE Detail with inclusion code = PART

## (FTES-007) Transfers

- Contains FTEs that will either transfer in or out from the LEA receiving the report
- Displays FTEs that transfer in as positive amounts and FTEs that transfer out as negative amounts
- Can be generated for any LEA type
- Includes FTEs for students who are
  - in preschool open enrollment situations
  - in specific non-open enrollment situations
  - preschool students attending an ESC

## (FTES-007) Transfers Result Codes

- FT0150 - Preschool open enrolled in, initially funded elsewhere and funding transferred to educating LEA (positive amount)
- FT0160 - Preschool open enrolled out, initially funded then funding is transferred to the educating LEA (negative amount)
- FT0170 - Non open enrolled in, initially funded elsewhere then funding is transferred to educating LEA (positive amount)
- FT0180 - Non open enrolled out, initially funded then funding is transferred to the educating LEA (negative amount)

## (FTES-007) Transfers Result Codes, cont'd

- FT0210 - ESC Preschool student received from the resident district or a non-open enrolled district that is not the resident district; funding is transferred to the ESC from the district (positive amount)
- FT0220 - Preschool students sent to an ESC from the resident district or from a non-open enrolled district that is not the resident district; funding is transferred from the district to the ESC (negative amount)
- FT0221 - Preschool students sent to a County Board of Developmental Disabilities; funding is transferred to the County Board of Developmental Disabilities (negative amount)

## Quick Check

FTE Daily Summary Reports are helpful to identify fluctuations in FTEs that could affect funding. They can also be used to follow the flow of FTE funding based on student situations.

- Are you checking the Daily Summary Reports often to avoid any negative impacts on FTE funding?
- Do the numbers of FTE generated for the various attending situations align with your population of students?
- Are you sharing these reports with others in your district?



# Reviewing Your Student Data While Aligning FTE Reports with Payments

## FTE Reports Level 2 Open, Closed, and Archived

- Level 2 FTE reports in a closed collection contain the data that was last processed for that collection
  - Can be used to provide a historical view of data as of the close of that collection
- Level 2 FTE reports in an open collection contain the most recently processed data
  - Should be used to verify current data in preparation for data to be pulled for a payment and in preparation for the close of the collection
- Archived reports are generated when data is pulled for payments
  - Can be used to align data with payments

# Important

- Payments issued early in the fiscal year can use prior year data to generate the payment
  - Archived EMIS reports aligned with a specific payment will not align with that payment when prior year data is used
- Payment reports and archived EMIS reports sometimes do not match perfectly due to
  - Data being pulled for payment and EMIS reports being archived on different dates
  - Rounding from six decimal places in EMIS reports to two decimal places on payment reports

# What is Enrolled ADM?

# Filter Archived FTE Detail Report

- Filter out (and keep them filtered out as additional filters are selected)
  - State Equivalent Grade Level = Preschool
  - Inclusion Codes = NONE and PART
  - Note that students with Fund Pattern Code KGTU, FTE will need to multiplied by .5
- Set the below filters and remove before moving to the next bullet
  - FY25 Economic Disadvantage = Y, then Sum Adjusted FTE (data comes from FY25 FTED-001 Final No2 Payment)
  - FY26 Directly Certified ADM - Sum Adjusted CNDC FTE
  - Filter English Learner Fund Category = 1, 2, 3 (separate or together), then Sum Adjusted FTE
  - Gifted - Sum Adjusted Gifted FTE, also, could filter grade levels K-8 and 9-12
  - Career Technical Education - Sum Enrolled ADM CTE FTE for total CTE FTE
    - or filter Archived CTE FTE report by category (1,2,3,4,5) and sum Adjusted FTE
  - Current Year Open Enrolled in – Filter on OPDD, then sum Adjusted FTE
- These numbers can also be found on the FTES-009 and FTES-010 reports which will be reviewed on the next slides

# What is Base Cost Enrolled ADM?

  - Contains FTE data that is divided into specific categories
  - Is the larger of the prior year or trailing 3-year average
  - Can be verified using the Archived (FTES-008) Enrolled ADM FTE Summary – Prior three years data rows
- Archived (FTES-008) Enrolled ADM FTE Summary
  - Combination of three prior years data and the current year
  - First three rows contain prior three years data
  - Last row contains current year data at the time data was pulled for the payment
